

COLUMBIA/BOONE COUNTY SCHOOLS

Columbia and Boone County schools are strong, routinely producing some of the largest numbers of National Merit Scholars among Missouri public and private school districts.

Columbia Public Schools (CPS) is a PK-12 district accredited with distinction by the Missouri Department of Elementary and Secondary Education. The district is the fifth largest in the state and includes 21 elementary schools, six middle schools, four high schools, the Columbia Area Career Center, and an early childhood program. A seventh middle school is under construction and set to open in August 2020.

CPS high school students consistently achieve ACT test scores above the state and national averages, with the district providing for all high school juniors to take the test. Columbia students' 2018 average composite score is 21.7, higher than the average of Missouri test-takers (19.9) and the national average (20.8).

STAR assessment results indicate 73.1 percent of students are reading on grade level by the end of third grade. Nearly 77 percent of elementary students demonstrate proficiency in math. More than 2,300 high school students took advanced placement courses, with nearly 75.8 percent earning college credit.

The district graduation rate is nearly 90 percent, with nearly 75 percent attending college or post-secondary institution, compared to 66.7 percent statewide.

The Columbia Area Career Center has a graduation rate of 98 percent.

HIGHER EDUCATION



In addition to the University of Missouri flagship campus, Columbia boasts private universities, satellite campuses, and many other higher education opportunities nearby.

The UNIVERSITY OF MISSOURI was founded in 1839 in Columbia, representing the birth of public higher education west of the Mississippi River. Today, the 1,262-acre campus improves lives as Missouri's largest public research university and serves citizens statewide as a land-grant institution. MU offers 325 degrees and certificates through 13 colleges and schools. Among Missouri's public universities, Mizzou grants 27 percent of bachelor's degrees, 21 percent of master's degrees and 46 percent of doctoral degrees. MU has 30,046 students from every U.S. state and 122 countries and is a member of the prestigious Association of American Universities. Faculty, staff and students work hard to honor the public trust by upholding four values: respect, responsibility, discovery and excellence. COLUMBIA COLLEGE is a private, nonprofit liberal arts and sciences college that takes pride in small classes, experienced faculty and quality educational programs. Founded in 1851 as Christian Female College, the college changed its name to Columbia College in 1970. That year, it transitioned from a two-year women's college to a four-year coeducational college. CC has a traditional campus, more than 30 venues nationwide, an evening program in Columbia, and an online program. The college serves approximately 18,000 students annually. MU granted a total of 10,776 degrees in 2018-19. More than 30 percent of degrees awarded were in science, technology, engineering, mathematics or health fields.

MU IS AN IMPORTANT INVESTMENT

- MU's founders established the first public university west of the Mississippi River and the first state university in Louisiana Purchase territory.
- Many states fund separate research and land-grant universities, but Missouri combines those roles at its flagship institution. As the state's major public research university, MU solves problems and improves lives. As a land-grant institution, MU has a statewide mission of serving the public good.
- Mizzou is a member of the prestigious Association of American Universities (AAU), an organization composed of 65 leading institutions that transform lives through education, research and innovation. AAU members earn the majority of competitively awarded federal grants for research to improve health, address national challenges and contribute significantly to America's economic strength.
- MU is categorized with universities that conduct the most scientific research and offer the highest level of instruction. The Carnegie Classification of Institutions of Higher Education describes MU and only 130 other U.S. schools as "R1 doctoral universities" with "very high research activity."
- Among Missouri's public universities, Mizzou grants 27 percent of bachelor's degrees, 21 percent of master's degrees and 46 percent of doctoral degrees.

MU PROVIDES A FIRST-RATE EDUCATION FOR DIVERSE STUDENTS

- MU has 30,046 students from every U.S. state and 122 countries.
- MU's 2019 freshman class is diverse and academically gifted. First-time college student minority enrollment increased by 30 percent compared to last year. In addition, the class had a strong ACT average of 27, which is significantly higher than the state average of 20.8 and the national average of 20.7. At the same time, MU logged a record retention rate of 87.9, meaning nearly nine out of ten freshmen from last year returned this fall.
- Graduate programs, professional schools and the discovery of new knowledge through research add unparalleled value to an MU degree. Mizzou also offers many real-world experiences, including opportunities for civic involvement, humanitarianism, advocacy, leadership and stewardship.
- MU's endowed chairs and professorships help the university recruit nationally prominent scientists and scholars. Mizzou faculty excel at teaching and in their fields. They bring discoveries and creative achievements into the classroom, lead national groups, publish in prestigious journals, attract research grants and win major honors. In 2018, emeritus Professor George Smith won the Nobel Prize in chemistry.
- Hundreds of students each year conduct independent research under the guidance of MU's world-class faculty mentors.

MISSOURI INNOVATION CENTER

Bright Ideas Becoming Brilliant Companies

The Missouri Innovation Center (MIC) is home to startup companies based on MU faculty and student innovations. MIC recruits other young companies to Columbia to collaborate with MU researchers.

The Bond Life Sciences Center is a state-of-theart facility housing MU's top life scientists who work together to improve the quality and safety of food, prevent and treat disease and protect the environment.

RESEARCH REACTOR

PROVIDING QUALITY NUCLEAR PRODUCTS & SERVICES

The MU Research Reactor (MURR) is the largest U.S. producer of radioisotopes used in the diagnosis and treatment of cancer.

- MU students hold patents and start businesses. They own their intellectual property, manage an angel investment fund supported by the Kauffman Foundation, participate in business accelerators, and win major venture and pitch competitions.
- Last year, 6,086 undergraduates gained experience and earned credit by volunteering for 456 community and government partners. This service contributed an estimated \$11.5 million to the Missouri economy while meeting critical needs of citizens. In the past 12 years, MU students in service-learning courses have served over 2 million hours.
- By the time they graduate, 18 percent of undergraduates have studied abroad. Programs are available for every major in more than 40 countries.
- Mizzou has 1,634 international students (5.4 percent of total enrollment). According to the annual Open Doors report, international students contribute more than \$637 million to the Missouri economy each year.

MU RESEARCH GENERATES SOLUTIONS FOR OUR FUTURE

- MU research generates new knowledge and jobs; yields discoveries with commercial potential; gives students hands-on experience and prepares them to be scientific leaders; and creates a foundation for major advances in health, food, energy, communication and national security.
- MU has medicine, veterinary medicine, agriculture and engineering on the same campus, along with the nation's only NIHfunded university rat and swine centers, and the most powerful university research reactor in the U.S. The university provides industry partners with faculty expertise, licensable innovations, state-of-the-art instrumentation, and research and business infrastructure.
- In 2018, MU Chancellor Alexander Cartwright set the ambitious goal of doubling the university's research funding in five years. In 2019, grant funding increased by \$48 million over the previous fiscal year, and Mizzou experienced a 29% increase in grant proposals totaling more than \$1 billion. These increases will provide the revenues that will increase research output and boost economic development in the region and state.
- MU's research enterprise as a whole remains robust. Internal research investments and extramural funding support generated more than \$210 million in research expenditures in FY2019. Newly awarded dollars, most coming in the form of highly competitive grants from agencies such as the National Institutes of Health and the National Science Foundation, also saw solid year-over-year gains.

- Examples of first-rate interdisciplinary research environments at MU include the Thompson Center for Autism and Neurodevelopmental Disorders, the Christopher S. Bond Life Sciences Center, the Dalton Cardiovascular Research Center and the Donald W. Reynolds Journalism Institute.
- The NextGen Precision Health Initiative, the top capital priority of the UM System, is expected to accelerate medical breakthroughs for patients in Missouri and beyond, increase collaboration among university scientists and industry partners, attract research funding, generate jobs, and train a new generation of health care scientists and practitioners who will help Missouri address the health care needs of the future. The NextGen Initiative is supported by the Alliance for Precision Health, which will leverage UM expertise in collaboration with Siemens Healthineers, a global pioneer in medical technology.

MU POWERS THE ECONOMY

- The Association of Public and Land-Grant Universities designates MU as an "Innovation and Economic Prosperity University" for spurring economic development through innovation, entrepreneurship and workforce development.
- MU's economic impact on Missouri in FY17 was \$3.9 billion, according to a study conducted by Tripp Umbach.
- With about 17,000, MU is one of the state's largest employers.
- Mizzou educates the workforce, granting a record 10,776 degrees in 2018-19. More than 30 percent of degrees awarded were in science, technology, engineering, mathematics and health fields.
- More Missouri physicians have earned medical degrees from MU than from any other university, almost two-thirds of the state's veterinarians are graduates, and law alumni serve at every level of the state judiciary.
- MU has nearly 340,000 alumni worldwide, 182,546 alumni in Missouri, 34,575 alumni in the Kansas City area and 70,449 alumni in St. Louis.
- Hundreds of alumni and friends are supporting the historic \$1.3 billion *Mizzou: Our Time to Lead* campaign to endow resources for MU's future, support signature research centers and institutes, and fuel a campus renaissance.

MU CULTIVATES AN ECOSYSTEM FOR ENTREPRENEURSHIP

- Research initiatives and funding generate faculty innovations, some of which are licensed, patented and further developed in commercial settings. In FY19, Mizzou signed 61 license and option agreements with companies and was issued 40 U.S. patents. In fact, during the last three years, MU's licensing income totaled more than \$12.8 million.
- MU is consistently in the top 25 percent of the nation's higher education institutions for total gross licensing income, according to annual U.S. Licensing Activity Surveys conducted by the Association of University Technology Managers. License agreements allow companies to access university-owned innovations. In FY2019, companies optioned or licensed 103 different inventions.
- Examples of Mizzou ventures and products: Organovo, based on MU's 3-D bioprinting technology that builds living tissues, is now traded on the New York Stock Exchange; Beyond Meat, a plant-based meat substitute, is available in more than 21,000 stores and restaurants; OBERD has become the world's largest orthopedic outcomes database; and heartburn medicine Zegerid has achieved well over \$1.5 billion in net sales worldwide.
- MU's Office of Economic Development runs innovation and entrepreneurship programs to help students and faculty, creates meaningful partnerships with industry, and generates revenue via technology advancement and commercialization.
- The Missouri Innovation Center (MIC) helps launch startup companies, many from student and faculty discoveries, providing resources, mentoring and assistance with financing.
- MU's Coulter Translational Partnership Program accelerates the translation of biomedical innovations into products that improve patient care. The program bridges the gap between academic research and industry by providing engineer-clinician teams with the funding and resources needed to de-risk their technology and attract more funding to continue the commercialization process.
- The Mizzou Venture Mentoring Service is an educational program and consulting service that recruits successful business and community members to provide confidential mentoring to aspiring entrepreneurs, creating a culture that helps Missouri retain the best and brightest entrepreneurial minds.
- Entrepreneurship education at MU creates economic opportunities for students and teaches them to think unconventionally, problem solve, take risks and persevere. The new Entrepreneur

Quest program offers students an opportunity to create ventures based on their innovative ideas. EQ provides workshops, tools and mentoring to help students from any degree program transition their ideas into viable business models ready to pitch for up to \$30,000 in seed funding.

MU FACULTY EXCEL AT TEACHING AND THEIR FIELDS

- MU's faculty bring discoveries and creative achievements into the classroom, publish more than 2,000 books and scholarly articles each year, and attract millions of dollars from public and private sources. Examples from 2019: \$24.8 million in federal funding for a plant bioscience laboratory building; a \$10 million gift from the Kinder Foundation to support new degree programs; an \$8.6 million grant from the National Institutes of Health to establish a national Swine Somatic Cell Genome Editing; a \$6 million gift from Jim Fitterling for the NextGen Precision Health Institute; a \$4 million gift from Michael Budds to establish the Budds Center for American Music Studies; and a \$1.4 million grant from the National Science Foundation to help develop cyberinfrastructure across the Midwest.
- With 16 agricultural research centers, farms and forests across Missouri, and MU Extension innovations for farmers and ranchers, Mizzou is leading the way in improving global food security.
- Of MU's ranked, professional faculty, 92.8 percent hold doctorates or the highest terminal degree in their fields.
- The UM System has made the list of "Top 100 Worldwide Universities Granted U.S. Utility Patents" since 2013 when the National Academy of Inventors and the Intellectual Property Owners Association began publishing the ranking to highlight faculty innovation.

MU SERVES THE PUBLIC GOOD

- MU's founders established the first state university in Louisiana Purchase territory with the belief that a diffusion of knowledge among the people is essential for a free society.
- MU is classified by the Carnegie Foundation for the Advancement of Teaching as a "Community Engaged Campus" for stellar public service.
- MU Health's 7,000+ employees work in one of the state's most comprehensive health care networks, which includes five hospitals, and numerous primary and specialty clinics.
- MU Extension, supported by a partnership with federal, state and local governments, takes university knowledge to Missouri's 114 counties, Kansas City and St. Louis.

DALTON CARDIOVASCULAR RESEARCH CENTER

Center of Excellence in Cardiovascular Research

Interdisciplinary research is the hallmark of the university's Dalton Cardiovascular Research Center. Mizzou scientists from such fields as biochemistry, engineering, medicine, physiology and veterinary medicine come together and apply their particular expertise to health problems like hypertension, cancer, cystic fibrosis and heart disease.

SHARED RESOURCES FOR RESEARCH

MU's core facilities provide centralized access to instruments, technologies, expert consultation and other services useful to higher education investigators and external clients from industry and business.



COST OF LIVING COMPOSITE INDEX









SALES TAX

Boone County's combined state and county sales tax rate is 5.975%. An additional sales tax, up to 1%, may apply within Transportation Development Districts (TDDs). Missouri has responded to the needs of industry by providing eighteen major exemptions from sales/use taxes. Some of those exemptions include:

- Machinery and equipment used in a manufacturing facility
- Machinery that abates air or water pollution
- Materials and supplies used to install the above
- Electricity consumed in the manufacturing process; provided the cost of the electricity exceeds ten percent of total production costs.
- Sales tax for 2020 in Columbia is 7.975%, except in TDD designated areas which may have a tax rate as high as 8.475%.

MISSOURI CORPORATE INCOME TAX

Missouri provides a solid business expansion foundation, financial and otherwise. Missouri taxes only income earned in Missouri, giving businesses a critical advantage. Starting January 1, 2020, Missouri's corporate income tax rate dropped to 4 percent, making it one of the most tax-friendly states in the U.S. Missouri also moved to a single factor, market-based corporate income tax apportionment model based only on sales. In addition, it is important to note that Missouri has not adopted worldwide or nationwide unitary tax assessment in computing multinational corporate income tax liability.

PROPERTY TAX

Personal property equipment is assessed at $33^{1/3}$ % of fair market value.

- The inventories of manufacturers, retailers, distributors and wholesalers are exempt from property tax.
- Agricultural Property is assessed at 12% of fair or true market value.
- Residential Property is assessed at 19% of fair or true market value.
- Real property (land and building) classified as commercial or industrial is assessed at 32% of fair market value.

Assessed Value is a percentage of the market value as determined by the Assessor's Office. In order to calculate the assessed value, multiply the market value (or appraised value) by the appropriate assessment rate for the type of property. For example, residential property assessed at \$100,000 x 19% = \$19,000 then \$19,000 divided by \$100 = \$190 then \$190 x \$6.59 = \$1,252.10 taxes owed. UNEMPLOYMENT INSURANCE

Missouri unemployment benefits provide temporary compensation to those workers meeting the eligibility requirements of Missouri law. The value and duration of unemployment benefits vary from state to state because each state unemployment office applies its own formulas and limits within federal guidelines when calculating the level of unemployment compensation. WORKERS COMPENSATION

Missouri employers are required to carry workers' compensation insurance if they have five or more employees. Missouri employers involved in the construction industry are required to carry the coverage if they have one or more employees. This applies to all employers, regardless of whether the employees are part-time/casual laborers, full-time, or family members.

Members of an LLC and officers of a corporation apply towards this employee count, sole proprietors and members of a partnership do not.

Sole proprietors and members of a partnership are not themselves covered unless they elect, with their insurer, to be covered; close family member-employees and members of a limited liability company are presumed to be covered unless they opt out with their insurer.

Those subject to providing workers' compensation insurance for their employees must either go through an insurance carrier or may choose to be self-insured upon approval from the Division. GROSS RECEIPTS

Like most Missouri cities, the City of Columbia levies an in lieu of gross receipts tax payment on monthly utility services within the City of Columbia. The current rate is 7.5268%.

EQUITY INVESTMENT

Centennial Investors was created to meet the early capital needs of university and private sector entrepreneurs. TRANSPORTATION AND UTILITIES

Access to major highways, a regional airport and rail service increases delivery speed of goods and services to and from mid-Missouri. The central location also minimizes shipping costs.

American Airlines offers round trips between Columbia Regional Airport (COU), Chicago O'Hare International Airport (ORD), and Dallas/Fort Worth International Airport (DFW); United Airlines offers round trips between Columbia Regional Airport (COU), Denver International Airport (DEN) and Chicago O'Hare International Airport (ORD). Columbia Regional Airport is located 10 minutes south of Columbia off U.S. Highway 63. The airport's primary runway (2-20) is 6,500 ft long. The crosswind runway (13-31) is 5,500 ft long.

General Aviation Services provided by Columbia Jet Center (www. ColumbiaJet.aero) include: fuel services, aircraft management, aircraft sales, hangar space, pilot services, flight instruction, light twin aircraft charter service, and professional charter handling. Aircraft maintenance services are provided by Columbia Avionics (www.ColumbiaAvionics.com)

Kansas City International Airport (two hours west) and Lambert St. Louis International Airport (90 min. east) are each served by multiple major airlines.

CENTRALIA

Centralia, Missouri, is the second largest community in Boone County and is located approximately 25 miles northeast of Columbia. Centralia was founded in 1857 as a station on a new railroad approximately half-way or central to the railroad from St. Louis to Ottumwa, Iowa. Today, Centralia is served by the Norfolk Southern and Kansas City Southern national rail lines and by the COLT Railroad.

Centralia is the home of Hubbell Power Systems, the largest manufacturer in Boone County and an internationally recognized leader in manufacturing and distribution facility of equipment for electrical distribution systems. The city is a steadily growing residential community with 4,000 citizens and a growing retail trade center. A high value is placed on education through support of a modern school system and a nationally-recognized local public library.

Centralia has established an Enhanced Enterprise Zone (EEZ) that offers aggressive tax benefits for new or expanding industrial employers. The City has active partnerships with REDI, the Regional Planning Commission and the Centralia Area Chamber of Commerce to promote economic growth. The City of Centralia owns the electric, water and sewer utilities which allows better coordination of services for commercial and industrial prospects.

The Chamber website, www.centraliamochamber.com, has information on area businesses, Civil War history, area festivals and events including the annual Anchor Fest the first weekend after Memorial Day which is dedicated to the invention of the helical utility pole anchor by A.B. Chance in 1912.



HALLSVILLE

Hallsville, Missouri, was the second fastest growing city in Boone County, tripling in size in the last 15 years according to the 2010 Census. Just 10 miles north of I-70, it offers the ambiance of a quaint community with an excellent school district.

Hallsville has an Industrial Park, and a 120-acre zoned industrial site that is shovel ready. With many service businesses, a charming restaurant and a bed and breakfast, Hallsville makes a great day trip to visit its unique gift shops.
